2. TAX REFUND

Consideration should be given to approve the tax refund as presented. (see refund)

3. SUBSTITUTE LIST

Consideration should be given to add the following to the day-to-day substitute list contingent upon administrative assurance that all requirements are met: Haley Beachem (Summer Tech), Donna Procopio (Cafeteria)

4. RESIGNATIONS/RETIREMENTS

Consideration should be given to approve the following resignations/retirements:

- a. Analise Essinger as a Teacher's Aide effective May 31, 2024
- b. Susan Marich as a Teacher's Aide effective May 31, 2024

5. **LEAVE OF ABSENCE**

Consideration should be given to approve the request of Bob Reash to take a family medical leave beginning May 21, 2024, not to exceed twelve weeks.

6. FINAL BUDGET TRANSFERS

Consideration should be given to authorize the administration to make the necessary final budget transfers for the closing of the 2023-2024 fiscal year.

7. BALANCE OF CONTRACT PAYMENT

Consideration should be given to authorize the administration to make balance of payments to employees as requested and as provided by contract. (see employee list)

8. **INVESTMENT OF FUNDS**

Consideration should be given to authorize the Superintendent to invest funds as they become available during the 2024-2025 fiscal year.

9. HOMESTEAD AND FARMSTEAD EXCLUSION RESOLUTION

11. WORKERS COMPENSATION INSURANCE

Consideration should be given to name Arthur J. Gallagher Agency as insurance agents for the Board, with Encova as provider for Workers' Compensation Insurance coverage for the 2024-2025 fiscal year with an annual premium of \$34,050.

12. CYBER INSURANCE

Consideration should be given to name Arthur J. Gallagher Agency as insurance agents for the Board, with Travelers Insurance providing Cyber coverage for the 2024-2025 fiscal year with an annual premium of \$12,284.

13. **TENURE**
